Application and payment

The application fee is 100 Euro. This amount is to be credited on the course fee. In case of not-attendance the 100 Euro are processing costs. The application has to be in written form and the application is only valid upon receipt of 100 Euro .

The fee falls due 14 days before start of the course. Please make sure that the payment comes free of commission.

Withdrawal of course participant

The course participant can withdraw every time before the course. Important is the receipt of the written cancellation. It is almost impossible to find a new participant short-term. Therefore you have to pay: in case of cancellation 30 days before the course: 50 % of course fee; 10 days before the course: 100 % of course fee.

Please think about the travel cancellation insurance.

In case of non-attending parts of the clinic there is no right of compensation. Please think about insurance for curtailment of travel

Before starting the course the participant can replace a participant. Please send therefore a written notice. For changing the application we charge 25 EUR per Person. If the organizer comes up with a new participant we charge 25 EUR.

Liability and safety

The participation is of own risk. Underage persons have to wear a safety riding helmet. For adults we recommend it.

Photos

We eventually take photographs from the course. We are allowed to present them for marketing activities.

Excursions/ Swimming

I allow my child to take part at excursions and to go to the swimming pool.

Withdrawal and cancellation from the organizer

The organizer can withdraw or cancel the the contract in the following cases:

Without a time limit:

If the participant disturbs the course again after receiving a warning or the participant is behaving in contrarily to contract. If the participant has not paid the course fee. In those cases the organizer has the right for the whole

course fee.

3 weeks before the start of the course:

If the course cannot take part, because there are too less participants.

In this case the participant will get written notice and the application fee will be paid back at once.
